#### Advice from Certified Growers



As the inaugural year of the GAP Connections Certification program comes to a close, GAP Connections would like to thank all those who participated to make the first year such a success. The numbers exceeded our expectations as we finished with 475 GAPC Certified

operations, which encompasses 813 Certified Growers. Certified Growers represented 10 states and different tobacco types (151 Burley growers, 246 Dark (air and fire) growers, and 416 Flue growers).

GAP Connections recently spoke with growers who went through Certification and asked them to share their thoughts on the program and to offer advice to other growers who may be considering the program in 2019.

Linda Hughes, GAPC Certified tobacco grower of Hurtle Mills, North Carolina, believes that Certification is a great program and would recommend the program to anyone considering. "We were already doing a lot of documentation on our own, "stated Mrs. Hughes, "but having our records in writing makes them more verifiable and stresses the importance of our practices to our employees." When asked if it was difficult to achieve Certification, Mrs. Hughes pointed out that it takes time and organization. She stated her best advice to others is to dedicate time each day to document practices and records. Read more ...



#### 2019 Annual GAPC Training Dates

GAP Connections (GAPC) partners with Cooperative Extension in each state with GAPC Grower Members to coordinate annual GAP training for growers. In 2018, 7,443 growers attended 103 meetings in 12 states.

Annual GAP Training is a requirement of the GAPC Certification Program and must be completed by June 30 of each year for growers participating in the Certification Program.

If training is not completed by the grower and any listed associates on the Certification application by June 30 they will not be able to be Certified.
