



## GAP Connections Certification Application and Renewal Period is Now Open

Things to Remember:

- Application must be submitted by April 15
- If you became a GAPC Certified Grower in 2018, you are required to submit a 2019 renewal application by **April 15**
- Deadline for growers to contact approved auditing firm for best pricing is April 15
- It is VOLUNTARY. It is YOUR decision.
- Review the GAPC Certification Compliance Guide and List of Non-Remediable, Critical Certification Standards before deciding to apply. <u>View here</u>.
- All growers listed on the application must complete annual GAP Training by June 30

### 2019 Annual GAPC Training is Underway!

GAP Connections (GAPC) partners with Cooperative Extension in each state with GAPC Grower Members to coordinate annual GAP training for growers.

Annual GAP Training is a requirement of the GAPC Certification Program and must be completed by **June 30** of each year for growers participating in the Certification Program. If training is not completed by the grower and any listed associates on the Certification

application by June 30 they will not be able to be Certified.
