





# Hurry! Time is running out to apply for **GAP Connections Certification!** Deadline: April 15 at midnight

### <u>FAQ:</u>

- When is the deadline to apply for GAPC Certification? April 15 by midnight
- How do I apply for GAPC Certification? Visit www.gapconnections.com to log into your grower profile. Go to "Certification" and "Apply or Renew" to begin your application.
- I forgot my password: If you have a vaild email on file with us, you may reset via email. Otherwise, call GAPC office at 865.622.4606 to reset your password.
- I was GAPC Certified in 2018, do I still have to apply? YES! In order to maintain your GAPC Certification, you are required to submit a 2019 renewal application by April 15. Please remember to include any associated growers on the application. Failure to do so will result in that grower to lose Certification.
- Is there a cost for the application? Yes. First year applicants (growers not currently Certified): \$150 for online applications, \$200 for paper applications, \$50 for each associated grower. Second Year renewals (growers who are Certified): \$100 for online renewal, \$150 for paper renewals, \$50 for each associated grower.
- I've submitted my application, what's next? The primary grower will receive an email or mailed Certification Approval Packet which includes information on the four auditing firms, GAPC Audit Price Table, GAPC Certification Compliance Guide, and Certification Checklist. It is the growers responsibility to contact an auditing firm by April 15 to schedule the audit/site visit. Expect 2-3 business days for the application to be approved.

- I have Associated Growers on my application, what do they need to do? After the application has been approved, the Associated Grower must login with their Grower ID and password to accept the Terms & Conditions. When the Associated Grower logs in, a RED BOX will appear on their dashboard. Click on the box to complete the Terms & Conditions for Certification.
- Where do I send my FSA 578 form? We recommend uploading the FSA 578 form within the application. However, if you are unable to do so you may fax (865.622.4550), email (info@gapconnections.com), or text (865.622.4606) to GAPC office. Application will NOT be reviewed until we have all forms. Year 2 applications do NOT have to submit a 578 form. ALL growers must present 2019 FSA 578 form at time of farm audit or site visit.
- I have missed training, what do I do? Contact your county Extension Office to schedule a time to watch the training video. All growers listed on the application must complete annual GAP Training by June 30. View calendar of training HERE.
- Other requirements? 2019 Self-Assesment must be complete by time of audit or site visit.

## 2019 Self-Assessment

The self-assessment is available now at www.gapconnections.com. To complete, log into your profile via our website at www.gapconnections.com. On your Grower Dashboard go to "Self-Assessment" > "Grower Self-Assessment".

### Reminders:

- Growers going through the GAPC Certification program are required to complete the Self-Assessment by the time of the audit/site visit. It is one Self-Assessment per operation.
- The Self-Assessment will auto save after every 10 minutes. If the screen goes blank, don't panic, it's just saving.
- · After a question is answered the box will turn blue. Any grey boxes are the ones you will need to answer.
- The percentages will update at the top of the page each time you submit your answers. Depending on the speed of your internet the new percentages could take 5 seconds to 15 seconds to update.
