

## 2021 GAPC Certification Program

All growers participating in the GAPC Certification program must apply every year in order to maintain Certification.

#### **How to Apply**

- 1. Visit <u>www.gapconnections.com</u>
- 2. In the upper right hand corner, find "Log In" "Log In to View Member Tools"
- 3. Enter your 6 digit Grower ID number (found at the bottom of your GAP card) and password. Passwords may be reset via email (if valid email address is on file) or by calling GAPC at (865) 622-4606
- 4. Find "Certification", then "Apply". Click "Start One" to begin a 2021 Certification Application. 5. Complete the application. You know you have come to the end
- when you submit payment.

# **Pesticide Disposal and Recycling Programs**

Farmers spend their days working and tending to the land, shepherding a responsibility to protect the land and the environment they farm in for their

family, their community and future generations. One-way farmers are honoring this responsibility is by properly disposing of pesticides and recycling the empty containers.

#### **Proper Disposal**

Improper disposal of pesticides pose a real threat to the environment and can lead to potential contamination to soil, surface water and ground water. However, the risk of serious incident can be lessened if proper management and disposal methods are used.

One method of disposing of unused pesticides is to contact the pesticide manufacturer to see if they will take it back. Another method is to ask other possible users such as other farmers or neighbors of the pesticide to see if they have a use for it. For legal reasons, never sell a pesticide unless you are a licensed dealer. Both of these suggestions are based on the assumption that the pesticide is in the original, fully labeled container.

Look for programs (i.e. Chem Sweep, Clean Sweep, Pesticide Collection Programs) in your state that offer services to help you properly dispose of unused or unwanted pesticides. Many of these programs are run by the Department of Agriculture in partnership with University Extension programs in each state. #### Recycling


Many pesticide containers can be recycled after they have been emptied and rinsed thoroughly. The benefits to recycling include reducing the amount of waste sent to landfills and incinerators, saving energy and conserving valuable resources. Also, a less known but not less meaningful fact about recycling is that it strengthens our economy and creates jobs. According to the 2020 EPA Recycling Economic Information (REI) Report, recycling created 681,000 jobs, \$37.8 billion in wages and \$5.5 billion in tax revenues in the United States.

Containers properly prepared for recycling have had their caps removed and been emptied, triple or pressure rinsed and dried.
